It should be noted that an attorney-client relationship does not come into being with just one request. However, we will also treat information resulting from such requests as confidential. All people working for the clinic are familiar with the current data protection and confidentiality regulations and have been trained accordingly.

# INFORMATION ON DATA PROTECTION

Dear client,

The protection of your personal and animal-related data is very important to us. The EU General Data Protection Regulation (GDPR) regulates data protection rights and obligations.

This information explains why our clinic collects, processes, stores or forwards data.

## 1. **RESPONSIBILITY FOR DATA PROCESSING**

## 2. PURPOSE OF DATA PROCESSING

The treatment contract imposes legal obligations on us (Art. 6 GDPR ff). We process your personal data as a client and additionally the personal data and health data of your animal.

Health data includes the history of the disease, findings collected, diseases diagnosed and suggestions/measures for healing. If your animal has been pre-treated in a veterinary practice, we may receive data from there or you can bring it with you yourself. The data may contain results from third parties (e.g. laboratory, pathology, etc.).

The collection of health data is a mandatory requirement for the treatment of your animal, the use or delivery of medication, the distribution of feed, feed additives and articles and for statistical evaluation. Without the necessary information or its processing, we cannot provide any of the aforementioned services.

The legal basis for the processing of your data is Article 9 Paragraph 2 Letter h) GDPR in conjunction with Section 22 Paragraph 1 Number 1 Letter b) Federal Data Protection Act.

## 3. CATEGORIES OF DATA WE PROCESS

The processing of personal and biometric data is permitted to clearly identify the holder, in deviation from GDPR Article 9 Paragraph 1.

The data is necessary for health care, medical diagnostics, care or treatment and for the management of systems and services in the veterinary field based on the contract between you and our clinic.

This data is processed by or under the responsibility of specially trained personnel who are subject to an appropriate obligation of confidentiality.

## 4. RECIPIENTS OF YOUR DATA

Recipients of your personal or animal-related data can be people you specify (spouses, life partners, other people) and veterinarians.

Other recipients may include veterinary laboratories, pathological institutes, veterinary associations, the Paul Ehrlich Institute (PEI) of the Federal Ministry of Food and Agriculture (BMEL), possibly other authorities, your animal health or surgical insurance and the veterinary clearinghouse. The list of current service providers (laboratories, pathology, etc.) is posted at the registration desk for your information.

The transmission is carried out unencrypted by email, via interface or fax for various purposes (diagnosis determination, information from your pet doctor/re-treating veterinarian, invoicing and settlement of the services provided, consumable goods, medications used or dispensed, clarification of veterinary questions or questions arising from your insurance relationship, emergency treatment). In individual cases, data may be transmitted to other authorized recipients.

There are currently no plans to transfer data to a third country or to an international organization.

## 5. STORAGE OF YOUR DATA AND YOUR RIGHTS

We store your personal data, information about the animal and the respective course of treatment for 10 years after the last treatment. For invoice customers, we store the current status of invoice acceptance for 3 months after the last query.

You have the right to request the correction, blocking, deletion or data transfer of this data at any time, as well as to revoke your consent at any time. Your data will be deleted unless there are legal regulations - in particular retention periods - to the contrary.

We only need your consent to process your data in exceptional cases. In these cases, you can withdraw consent for future processing.

You also have the right to complain to the responsible data protection supervisory authority.
